Spring Social Report

Our Spring Social evening was held on Friday April 15th, with around 60 people attending. We were treated to an interesting talk by Mike Burrell, head of Planning Policy at Norwich City Council, which covered the various ways Norwich Council is trying to make their city centre a modern, vibrant place for shopping, entertainment and daily living. Mike stressed the need for an overall strategic plan and the importance of ensuring a reliable transport infrastructure was in place, to encourage the use of buses, cycling and walking and to discourage people driving through and into the centre of town. Norwich has a strong, thriving town centre which is now among the top 15 nationally. The success is partly due to joined-up planning, with the City Council working together with the County and neighbouring District Councils, as well as successful applications for funding from Government and European sources. Mike detailed plans to limit car access through the use of six Park & Ride sites, as well as measures to promote independent shops, culture and tourism and the late-night economy. The Council is trying to encourage people working in the centre to stay on in the evening and enjoy the leisure and restaurant facilities on offer. Mike highlighted difficulties due to recent Government planning policy changes, for example the ease of conversion of offices into flats.

Both Mike Burrell and Chris Rand, from St Edmundsbury Borough Council, answered questions from members. In both Norwich and Bury, Council officers are aware that signage and access to the centre on foot from the railway stations need improvement. The impact of Guildhall Feoffment School's expansion on local traffic was discussed. Chris highlighted the potential adverse effect on traffic flows of the proposed sixth form college on the King Edward's/West Suffolk College site. Mike noted that at new schools in Norwich, parents are not allowed to drop children off by car within a designated area around the school, although he thought this would be difficult to enforce on existing sites.

Overall this was a worthwhile and informative session. Some problems were noted with the sound system, which we hope to rectify at our next meeting, the AGM in October.

GUILDHALL

Since our last update to you there have been three highly significant events.

First, we have been very lucky to welcome Sarah Green onto the Bury St Edmunds Heritage Trust Board. She has already brought her commitment and imagination to our discussions and our decision making. She represents us on the Tourism group and we look forward to her continued active contribution to the Guildhall Heritage Centre project.

Next, we have completed the repairs to the front roof of the Guildhall. This turned out to be a much bigger task than we estimated when we set out on our project some years ago. Erecting the scaffolding alone was a major task in terms of time, scale and cost. Then the whole roof had to be stripped, the supporting framework inspected, and more than half the tiles replaced. There were also repairs to the brickwork and parapets. Thanks to excellent support from our architects and outstanding workmanship from the contractors the final result is not only secure but also sympathetic, with the front aspect mostly tiled with original materials and the overall appearance largely restored. Historic England, one of the major donors, is very impressed with the outcome, and we can feel much happier that this part of the building and the rare timber roof structure beneath the tiles will be safe for many years to come. You may be interested that in the course of the work we also had the timbers subjected to examination by a dendrochronology expert in order to settle once and for all the date that they were put in place. We are still waiting for the results of that work.

Finally, we have just heard that after a lot of hard development work, briefing sessions and cross examinations, we have been awarded a provisional grant of £669,000 by the Heritage Lottery Fund (HLF) towards the delivery of our project. This is of course good news, not only because it promises to enable our vision for the Guildhall but, equally important, because it is a thorough endorsement of that vision. The HLF does not offer grants lightly and in doing so it is making a statement; that after professional scrutiny it judges our project to be a significant enhancement to our national heritage, good value for money, and based on a sound business plan. We have been awarded this provisional grant in the face of stiff competition and it is a cause for local celebration, but there is a catch. The grant is conditional on our raising the balance of the cash cost of the project of £1,500,000. We have already spent £170,000 on the front roof but even so we believe that we can identify another £500,000 towards the rest of the project. But that leaves us about £330,000 short of the target. Moreover at present the HLF is only allowing us until 7th October to find the money, so you can see that having got so near we are still faced with a huge challenge over the next six months. We are pulling out all the stops and exploring all the options that we know in order to close that funding gap.

However we need help, local help, your help. Please would you do whatever you can to help us raise those funds. We are open to ideas, introductions, cash even!

Police News: Call 999 (or should that be 101?)

Nationally, more than three quarters of 999 calls received by police are for non-emergencies. Returning home to find your house has been burgled or your car stolen is a serious matter – should you call 999? The police will treat the matter as serious but want you to use 101 to report it (as it is no longer a 'crime in progress'), leaving 999 for emergencies.

Of the 284,000 calls per year (both 999 and 101) received by Suffolk Constabulary's Contact and Control Room, only 20% of these relate to crime. The remaining 80% are made up of administrative calls, or relate to anti-social behaviour, public safety, welfare or transport. A large number of calls are received that do not relate to police matters. The police are often the 'service of last resort' – people call the police when they don't know who else to call. The commitment of police to public safety means that officers are sent to calls for help that are not police-related and are therefore diverting resources from emergencies.

To tackle these issues, the Constabulary is working to improve its online services to make sure that more information is readily available through its website to answer queries and to direct members of the public to the correct agency, and through raising awareness of the correct use of police numbers and the breadth of policing demand. Consultation on Alpha Parking review report Zones D and F

Residents and businesses in the Churchgate area should have recently received a hand-delivered form for comments on the draft recommendations following the parking review carried out in November 2015. Comments should be returned on the forms or given to the <u>drop-in session</u> being held at the <u>Unitarian</u> <u>Meeting House</u> on <u>Wednesday May 4th, 2 - 7pm</u>. You have until May 13th to return the form.

The draft recommendations include many of the points the CAA have already made following members' feedback. These include the expansion of the number of residents' parking spaces, extension of the residents'-only parking times, restrictions on use of resident permits and policing of illegal parking.

Note that no decisions have been made at this juncture, so your response is still very much needed to influence the outcome. It will still be up to our Councillors to agree to the recommendations.
